Who is Borrego Health

Borrego Community Health Foundation, (d.b.a) Borrego Health, is a 501 (c) 3 non-profit corporation and Federally Qualified Health Center since September 2002.

The mission of Borrego Health is to provide primary and specialty care services focused on reaching the underserved communities in Southern California. Borrego Health provided 1.2 million patient care visits in 2019 throughout its twenty-eight (28) brick and mortar clinics, twelve (12) contract medical sites, and ten (10) mobile units serving San Diego, Riverside and San Bernardino counties.

Our primary focus is the underserved, with an empowered workforce providing measurable quality and compassionate care to its 267,209 patients. 90% of those are low income living below 200% of the Federal Poverty Level (FPL) and 70% live in poverty. Approximately 67% are Medi-Cal (Medicaid) recipients or participate in other public health programs. Our patient population consist of 33% are under the age 18, and 91% are under the age of 65.

In terms of patients served, in 2019 Borrego Health was recognized as the largest FQHC in California and the second largest in the country.



Who is Borrego Health (cont.)

Borrego Health provides Primary Care Services that include Family Practice, Pediatrics, OB/GYN, Internal Medicine, Podiatry, Dermatology, Cardiology and HIV/Hepatitis C care. The organization also provides Dental, Behavioral Health and Chiropractic services, Transgender Health, Urgent Care, School-Based Health and Telehealth.

Additional patient services includes insurance eligibility and application assistance, referral assistance, community resources, and patient shuttle service.


Borrego Health has attained Level III Patient Centered Medical Home recognition by NCQA at ten (10) clinic locations.

Is operating its first year of being an ACGME accredited Family Practice Residency program (ACGME Institutional Accreditation).

Borrego Health operates a Health Homes Program which is a Department of Health Care Services program that integrates behavioral health and care coordination for the high risk and high utilization Medi-Cal eligible members of the health plan. (formally a Behavioral Health Integration Coordinated Care Initiative (BHI-CCI) project.

Current State: ACEs Screening & Response

Currently Borrego Health, is not formally assessing for ACEs via ACEs-Q or PEARLS. We use various questionnaires that touch on trauma and social determinates of health and will informally assess during in-person conversations with patients. We conduct assessments currently...

- Within a HealthySteps Project (Zero to Three), a screening tool called the "Family Needs Questionnaire" has additional questions that can trigger the conversation to touch ACEs and toxic stress the families perhaps are experiencing. This is used by the HealthySteps team (HealthySteps Specialist).
- An internal collaborative made up of operational and medical leadership is currently developing a process to address Social Determinates of Health in a manner to capture the required data but limiting the amount of questionnaires a patients is required to complete. Patients are completing multiple time consuming questionnaires, the redevelopment of these will reducing duplicate questions and making the questionnaire comprehensive and meaningful.

- BCHF has many programs that are built around trauma-informed care, such as the HealthySteps Program, Healthy Homes Program, Behavioral Health and LGBTQ programs. BCHF understands that building a trauma-informed workforce / organization is not only crucial to the success of the numerous programs we are currently participating in, but it's crucial to the organization as a whole.
- It is the intention to gain expertise and support from the California ACE's Learning and Quality Improvement Collaborative to integrate and enhance the ACE-Q and PEARLS screenings to our current workflow. This will expand our support capabilities and develop a comprehensive and meaningful questionnaire for our patients. This opportunity will allow the organization the ability to screen and detect trauma, toxic stress and respond with early interventions. This will promote resiliency in our patients short and long term health.

What are you most proud of in your sites/system that others should know about?

• HealthySteps was implemented within the Pediatric Department at five (5) clinics locations throughout Riverside County, which strongly promotes and builds resiliency in families. The program involves a HealthySteps Specialists working in conjunction with the Pediatricians in addressing a child's social-emotional well-being and growth in a non-stigmatizing setting.
