Born in Nigeria, raised in New Jersey, then backpacking across all seven continents, shaped Tosan's views on how intersections across culture, policy and health impact vulnerable communities. Tosan believes access to affordable high-quality care is a cornerstone for a thriving society. He's on a life-long mission to advance equity and eliminate health disparities.

Tosan currently serves as the Chief Operating Officer of Zuckerberg San Francisco General; The City's Teaching Hospital, only Level 1 Trauma Center, largest Primary Care Center and only Psychiatric Emergency Service. His development of the system-wide strategy to advance Equity at ZSFG received the Best Project Award by the Disparities Solutions Center. In February 2020, Tosan was appointed by San Francisco's Director of Public Health to serve as the Deputy Commander of the City's COVID-19 Operations Center. In phase 1 of the pandemic, of the most densely-populated cities in the US, San Francisco achieved the lowest COVID-19 death rates, new case rates and highest testing rates. He also serves on the Board of Directors for Fred Finch Youth Centers, a 125 year-old organization providing mental health, transitional housing and social services to families across California.

Tosan previously served as the Director of Ambulatory Services at San Mateo Medical Center where he led the Health System's transformation of primary, specialty, dental and managed care operations. Under his leadership, California Association of Public Hospitals bestowed SMMC's Ambulatory Services with the Performance Excellence Award.

Tosan is a Fellow of the American College of Healthcare Executives and holds a Master's degree in Public Health from Montclair. He specializes in utilizing LEAN principles to advance operational effectiveness, quality outcomes and health equity.
