- KCS MAT program provides Shared Medical Appointments & Group Visit every Thursday.



KCS MAT Program & Psycho-Social Supports

- KCS Psycho-Social Supports for MAT patients is provided primarily by MAT Care Coordinator (MCC).
- MCC develops individualized treatment plan upon assessment and coordinates with Health Navigator and Behavioral Health Care Coordinator to provide support services as needed.
 - Access to KCS Health Center:
 - Medical
 - Dental
 - Psychiatry
 - Mental Health
 - Acupuncture (Chiropractic services to be added soon)
 - > Access to Every Women Care for cancer preventive care & BCCTP, a restricted MediCal program for cancer confirmed patients, eligible for only cancer related treatment

KCS MAT Program & Psycho-Social Supports

Other services provided:

- > Access to Social Services and Public Services
- > Access to California Reducing Disparities Project (CRDP) for indigent/non-insured
- > Access to Full Service Partnership (FSP)
- > Access to Early Intervention Services for Older Adults (EISOA)
- > Access to KC Services for SUD Counseling
- > Access to Domestic Violence Treatment Program
- > Access to Whole Person Care for patients experiencing homeless
- > Access to Nutrition & Education Obesity Prevention Program (NEOP)
- > Access to Citizenship & Immigration Services
- > Access to Navigator for parents of children with special needs (Regional Center & Dept. of Disability Services)





KCS MAT Program & Shared Medical Appointments/Group Visits

- Shared Medical Appointment & Group Visits
 - weekly psychoeducation/process group offered every Thursdays
- Group Structure: 60 minute group by led by MCC, followed by individual patient visits with waivered provider
 - Introduction, overview of group purpose, check-in: 5 10 minutes
 - Educational presentation: 15 20 minutes
 - Discussion: 10-15 minutes
 - Wrap-up, patient commitment to goals for coming week: 5 10 minutes

KCS MAT Program & Shared medical appointments/group visits

- Suggested weekly topics are available but flexible to address more urgent concerns of group members.
- 8 week program rolling year round:

Wk 1: Understanding Addiction

Wk 2: Recovery 101

Wk 3: Life Management

Wk 4: Relationships

Wk 5: Anger & Stress Management

Wk 6: Thoughts & Emotional Health

Wk 7: Mental Health in Recovery

Wk 8: Relapse Prevention



Key Learnings

- What have you learned so far?
 - Our biggest surprise was that there are only 2 FQHCs in Orange County that provide MAT program, and KCS is one of them.
- What are some early wins or successes from the change?
 - Trainings by expert provider for KCS providers and staff
 - Established P&P for our MAT program
 - Launched MAT program and started to promote it within our community
- Challenges
 - Our staff requires anti-stigma training.
 - What are doing to mitigate the challenges?
 - We contracted with an expert MAT provider to train our staff.
