



Transformation Accelerator Program: Mid-Atlantic Region



About the Program

The Transformation Accelerator expedites the pace of change and improvement in five safety net health centers working to transform care for the most vulnerable patients in Prince George’s County, Maryland. The program has two components: 1) customized technical assistance to help health centers identify pressing problems, establish clear goals, and evaluate progress towards their goals; 2) a shared project aimed at strengthening health centers’ capacity to improve population health and tell their value and stories to county representatives and community members. Population health management concepts that emphasize panel management, team-based care, using data to improve care, and in-reach and outreach activities will be covered in this two-year program that runs from January 2017 through December 2018.



Program Offerings

- **Monthly coaching calls** to help health centers achieve their goals and problem solve on challenges
- **Quarterly webinars** focused on best practices in population health management
- **Four in-person convenings** focused on peer sharing, skills-based training, and expert presentations on population health management
- **Site visits** to high performing health centers



Benefits

- **Advocacy:** Appeal to community members and policymakers through stories that exemplify health centers’ value and collective work to create healthy populations
- **Expert Faculty:** National leaders in care transformation who can share best practices for high performance
- **Funding:** Up to \$30,000 to offset program expenses and for technical assistance for meeting milestones in the program



Commitment

- Dedicate a **project team** throughout the project that at a minimum includes: a day-to-day lead, a clinical champion, and an administrative champion. Add team members, based on content
- **Participate** in all assessments, convenings, coaching calls, and evaluation activities
- Active engagement, including willingness to **share best practices and challenges** in the program
- Document goals and the health center’s roadmap in a “**charter for improvement**”
- Submit **quarterly reports** to share progress on selected measures
- Participate in **overall program evaluation** including semi-annual telephone interviews and quarterly feedback surveys

Specific Funding Conditions

Program Requirements

Your organization agrees to perform the following deliverables:

- Identify team to participate in the program, team to include at least one senior leader
- Attend monthly coaching calls
- Attend all convenings
- Actively engage by sharing information requested to demonstrate value and attend all virtual and in person meetings related to advocacy
- Complete Center for Community Health and Evaluation 4 interviews and 6 pulse surveys

Required Reports

Report templates will be provided by CCI prior to the deadline.

- Complete a Charter for Improvement
- Submit progress reports on 12/15/17 and 5/15/2018
- Submit Final Narrative Report and Budget Report on 12/31/18

Installments

The total grant amount is \$30,000. Three installments will be made as follows:
