# 3. Patient surveys (if feasible)

#### Survey topics

- Acceptability of discussing SDOH with clinic staff
- Attitudes about health clinics' activities to identify and address patients' SDOH
- Trust in clinic provider/staff
- · Loyalty to clinic
- · Changes in SDOH
- Changes in self-perceived health status
- Site specific questions if appropriate

#### 4. Collection of data from sites (if appropriate and feasible)

- Number of patients served
- Non-medical services they received
- Patients' reported SDOH needs
- Patient health, utilization and cost data (potentially pre-post data)

Timeline: likely at the end of the project although may also want to collect some data during the project year.
